- Class-size reduction was implemented in grades 1-3 in order to improve student achievement.

- Monthly awards assemblies recognized excellent efforts in the areas of academics, attendance, and behavior.
- Dedicated parent volunteers helped tutor students in academic areas to help strengthen students' ability levels.
- Nevada Reading Week and Book Fairs helped encourage reading as a life-long learning activity.

Goals and Objectives

Goal 1

Students in fifth grade will show an increase in writing proficiency on the Nevada Proficiency Exam in writing.

Objective(s):

The percentage of fifth grade students meeting and exceeding standards will increase from 63.2% to 68.2% for the school average in writing as measured by the Nevada Proficiency Examination in writing.

Goal 2

Students in grades 3 and 5 at David M. Cox ES will show increased achievement on the reading CRT.

Objective(s):

All third grade students will increase the percentage of correct answers from 79.1% to 89.1% and all fifth grade students will increase the percentage of correct answers from 68.8% to 78.8% in the content standards of Read to Comprehend and Interpret and Evaluate Literature.

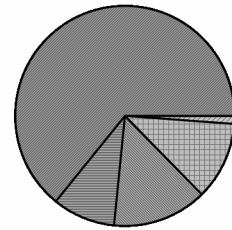

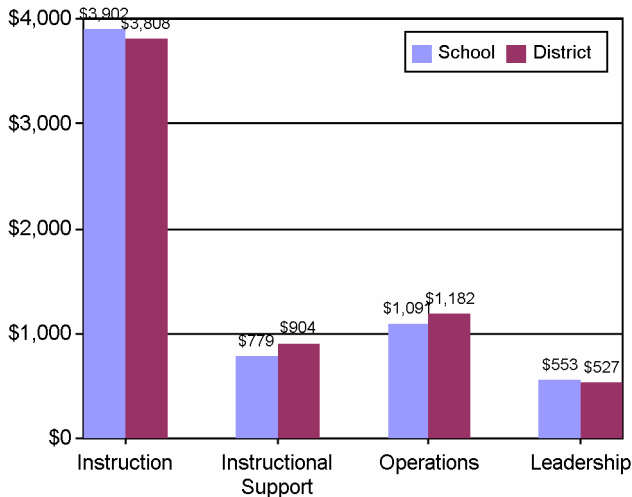
