### Mission Statement

Greenspun Junior High School is committed to providing a safe, positive and rigorous learning environment where students can become responsible citizens and life-long learners.

### Principal's Highlights

Greenspun Junior High School maintains a tradition of excellence, where student achievement is the top priority, and all students are encouraged to excel beyond the minimum requirements.

- 177 eighth grade students successfully completed Algebra I Honors and Algebra 1 for high school credit.
- 110 eighth grade students successfully completed Spanish I and 25 completed German I for high school credit.
- Students participated in technologically advanced curricular opportunities which included Read 180 and SkillsTutor.
- 896 students were enrolled in athletics, intramurals, clubs, and organizations.
- All IEP students received inclusion with general education students in science, social studies, and elective courses.
- Band, choir, and orchestra students received superior ratings at festival.
- 40 students participated in an after-school tutorial program to assist students with IEPs in mathematics and language arts.
- 57 students participated in the Grade 6 Academy, an intensive intervention program for non-proficient students.
- Students are recognized for earning Dolphin Cards, Student of the Month, Zero Missing Assignments, and Straight A's.

### Goals and Objectives

#### Goal 1

Increased achievement by IEP students in the content strand of Organize, Display, Read, and Analyze Data.

#### Objective(s):

8th graders will increase the percent of correct responses on the mathematics CRT. IEP will increase to 22% the content strand of Organize, Display, Read, and Analyze Data.

#### Goal 2

Increased achievement by IEP students in Read to Comprehend, Interpret, and Evaluate Informational Text.

#### Objective(s):

8th graders will increase the percent of correct responses on the reading CRT. IEP students will increase to 31.1% in Read to Comprehend, Interpret, and Evaluate Informational Text.

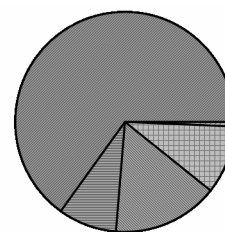

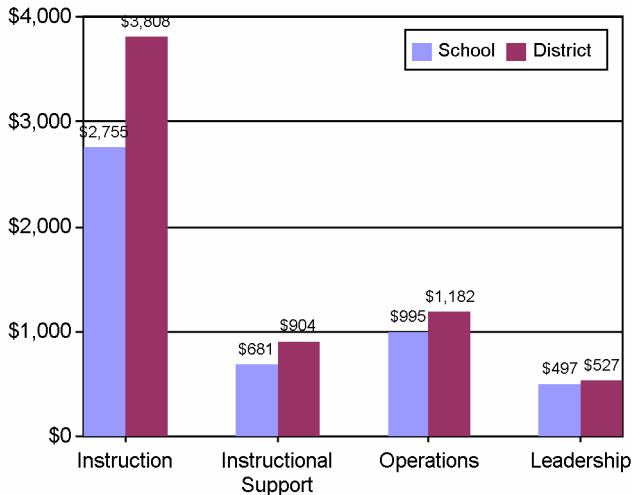

## Parent/Community Involvement

The administration and staff of Greenspun JHS provide for regular communication with parents, family, and the community in numerous ways. Quarterly newsletters are issued. Postcards and flyers are sent home as reminders regarding upcoming events. Traditional conferences are held weekly and progress reports are sent home quarterly. A computerized autodialer is used to record and send important messages directly to each home's phone or answering machine. Parents are notified daily through the autodialer if their student has any recorded absences. InTouch Online is also utilized as an interactive communication tool between the school and students' homes. Parents and students are able to see student records and school information online. This program allows parents and students to directly e-mail teachers regarding concerns or questions regarding student performance.
